- Eligibility: ORS 204.010; 204.016; 206.015; OR Const. Art VI Section 6; OAR 165-010-0005
- **Candidate Filing Period:** **September 11, 2025 – March 10, 2026\***
- **\* Incumbent Candidate Filing Period:** **September 11, 2025 – March 3, 2026**
- **Candidate Withdrawal Period:** **September 11, 2025 – March 13, 2026**
